Planned Infrastructure

The property is enclosed with a perimeter wall and serviced by a well graded marram road with paved walkways on the side. The side walks are shaded and landscaped with vegetation, street benches for relaxation when taking walks. The plots are serviced with a borehole piped water, foul drainage, electricity grid and a back-up generator.

Planned Facilities

Apart from shared management, he development offers a variety of common services within it; i.e.
